# The IOG is Governance

We are an independent, non-partisan public purpose organization that exists to advance good governance in public institutions, with public servants, and in the public interest.



#### **Our Work**

## **Applied Governance Advice**

The IOG provides governance advisory solutions and support to federal and provincial public sector organizations. We help mission-driven organizations to deliver on their mandates through good governance.

The IOG supported several public sector organizations in specific applied governance projects in 2022-2023

#### An Innovative, Multi-Stakeholder Corporate Structure

The Institute on Governance designed a new corporate structure for an arm-length federal government entity, with a mandate driven by innovation in the financial sector. The work, which was multi-stakeholder in nature, was designed to best support Canada's open banking system, while ensuring the structure remained consistent with Government of Canada practices and ministerial accountability.



# Internal Governance Review of a Federal Arms-Length Entity

The Institute on Governance reviewed and assessed the internal governance of a new federal agency to help it transition to a mission-driven and mandate-focused delivery organization with clarity on committee roles and processes.



#### Innovation, Research, and Governance

The IOG engaged innovation and research stakeholders in a province to develop consensus for a new provincial innovation governance model. The IOG's final report provided a series of recommendations for creation of a new provincial innovation agency and associated governance model.







#### Organizational and Process Review

The Government of Montserrat commissioned the Institute on Governance and Global Perspective Inc. in a joint venture to conduct a governmentwide organizational and process review. This project examined whether current structures, systems, processes, and staffing provided a sound basis to support the strategic vision of the nation. The project sought to identify actionable improvements to the government's system-wide structures and operations with a view to reengineering and digitizing service delivery to achieve better outcomes for citizens.

#### **Board Governance**

The Institute on Governance supports good governance for not-for-profit and distributed governance organizations, including Agencies, Boards, Commissions and Crowns of federal and provincial governments. We worked with over a dozen clients in 2023-24. Many of these projects were governance reviews to assess the current state of an organization's governance and provide recommendations for governance improvement. In some cases, the IOG was then asked to support implementation, including developing and/or updating policy manuals. Finally, the IOG provided a range of custom Board governance training sessions as well as facilitated Board retreats on focused topics such as the role of the Board, member engagement, and committee structures.

The IOG led a governance review of a large, provincially based not-for-profit as it considered governance improvements and approaches in response to a changing external context and demands. Work included a document review, a series of confidential internal and external stakeholder interviews, research on other relevant governance models, and preparation of a report on findings with recommendations.

The IOG prepared and facilitated a customized 2-hour, in-person training session for a Board of Directors of a charity. Topics covered included the Characteristics of High Performing Boards and the roles and responsibilities of individual Board directors, Board meeting good practices, Board committee good practices and the Board's relationship with the CEO.

#### International: Strengthening Inclusive Local Governance in Iraq

This project, funded by Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), sought to assess selected service delivery administrative processes in the water and municipal services sector and in the current management of citizen complaints in three governorates in Iraq. This assessment is the first step towards developing suggestions on how delivery of services and related administrative processes in these three areas could be improved, including through the better engagement of citizens in their design and delivery.



#### Learning and Leadership

This past year was pivotal for the IOG as learning offerings started to shift from being exclusively virtual to being in-person, as they were prior to the COVID-19 pandemic. During the transition, some registration patterns suggested that virtual offerings were still the preferred method of delivery. The IOG adapted to the post-COVID landscape by implementing hybrid models as a best of both worlds approach. All of our leadership programs now include an in-person delivery module.



#### Leadership Programs

The IOG provided Leadership Programs that prepare rising public service executives for the public service of tomorrow. Running between 4 weeks and 7 months, the IOG's Leadership Programs are masterclasses designed to set graduates apart from the pack. Between May 2022 and June 2023, the IOG provided learning and training services to 144 federal public service executives through our four leadership programs.

#### **Virtual Courses**

As fast track learning solutions, the IOG offers an array of highly specialized virtual courses designed to provide immediately applicable, skill-based training. In the past year, the IOG provided learning and training services to 1610 registrants through 27 courses and 4 leadership programs.

Public servants from multiple departments, agencies, and Crown Corporations participated.

#### **Custom Learning**

Custom courses, which are often created and provided for intact teams, are frequently delivered exclusively in-person, given the focus on team dynamics. We had a significant contract with a Crown Corporation, which involved training three staff cohorts, totaling 75 people.

The courses given were How Government Works, Policy, and TB/MC. The IOG provided learning and training services to 613 registrants through 17 custom learning offerings.

#### Nunavut

The IOG continued its long-standing relationship with the Government of Nunavut in 2022-2023 - now in our eighth year.

In 2022-23, we delivered two cohorts of Policy Foundations, one cohort of Policy Training, and one cohort of Advanced Policy Training. All of these programs were redesigned to be delivered virtually. These programs are highly customized to reflect the policy processes and issues of Nunavut, and also the history, culture and values of Inuit. The programs aim to build policy skills and capacity in the GN, and to bring more Inuit employees into policy roles.

In 2022-23, we also delivered one cohort of the Hivuliqtikhanut Senior Managers Leadership Program. This program is designed for Director level employees.

### Thought Leadership and Convening

The IOG had a productive year convening timely governance conversations for Canadians. We hosted public virtual and in-person events, including the following:

#### **Surface Robots Webinar**

In partnership with Global Advantage (September 2022), the IOG convened a free lunchtime webinar that examined surface robots and the Canadian AI landscape. Surface robots are small vehicles that operate with some degree of autonomy on sidewalks in uncontrolled settings. Read more on this piece on page 15.



#### **Rebuilding Trust and Transparency in Government**

In partnership with Evidence for Democracy (May 2023), the IOG hosted a lunchtime webinar exploring the critical issues of trust and transparency. The webinar discussed recently released research from both organizations on Canadians' trust in and perceptions of transparency about government decision-making.

#### Resilient Institutions Conference

Recognizing the unprecedented challenge that COVID-19 posed for public institutions at all levels, the IOG partnered with the Centre of Excellence on the Canadian Federation at the Institute for Research on Public Policy (IRPP) to convene a first-of-its-kind national conference dedicated to drawing lessons learned from the pandemic. Held in Ottawa in June 2023, Resilient Institutions: Learning from Canada's COVID-19 Pandemic was animated by four main themes: institutions of health, institutions of the federation, institutions of the public service, and institutions of democracy. The conference brought together over thirty roundtable participants, including senior policy practitioners from different levels of government, former and current elected officials, community organization leaders, Indigenous thought leaders, academics, scientists, and journalists, for a series of eight candid roundtable discussions. The IOG and IRPP will be releasing a report in 2024 with key messages from the roundtables, as well as a series of recommendations to make our public institutions more resilient in the future. ### **Publications**

#### Government Science and Innovation in the New Normal (GSINN)

Government Science and Innovation in the New Normal (GSINN), was a multi-year, collaborative research initiative designed to explore the impact of the pandemic on federally performed science and innovation, to support medium-term planning for federal science and innovation departments and agencies, and to provide insights to help rebuild the relationship between science and society.

The governance model that underpins Canada's relationship with science is based on a basic compact in which society supports science with public funds and assures the scientific community a great deal of autonomy in exchange for the considerable but unpredictable benefits that can flow from the scientific enterprise.

Today, many of the underlying social, economic, and political assumptions in the postwar compact are outdated. This project examined the relationship between science and society to imagine a new relationship, nine specific themes were identified:

- Equity, Diversity, and Inclusion;
- Global Research Collaboration and Infrastructure;
- Inclusive Innovation;
- Interdisciplinary Collaboration;
- Indigenous and Other Ways of Knowing;
- Mission-Driven Research and Innovation;
- Science Communications, Outreach, and Public Engagement;
- Skills and Knowledge; and,
- Trust, Integrity, and Science Ethics.

Taken together, these themes suggest elements of a new governance framework for science and innovation in Canada that embraces our current social, cultural and political realities, and recognizes the opportunities and limits of science. Perhaps most importantly, the project reinforces the role of science as part of society, and a tool ready to serve the needs of society.

The IOG presented the findings and conclusions of its research across the federal government's science sector.







#### **Surface Robotics Report**

Surface robots are small vehicles that operate with some degree of autonomy on sidewalks in uncontrolled settings. They are a relatively new area of technology and application of artificial intelligence that are known by many names, including Micro Utility Devices (MUDs) and autonomous ground vehicles (AGVs). These newcomers to Canadian sidewalks vary in size, speed, purpose, and functionality. Their presence has raised questions, concerns, and hopes. In November 2021, Transport Canada engaged the IOG to review the state of the technology, their use in Canada, and the related implications and impacts of this new technology. The IOG study by Rhonda Moore, Jeff Kinder, and Ezra Miller demonstrates that this new technology may offer social, economic, and environmental benefits to members of our community, eventually. However, at present, the technology is immature, the markets are undeveloped, and social concerns are yet to be addressed through further consultation, technology protocols, and standards and regulations
