Leadership Program Highlights



EXECUTIVE LEADERSHIP PROGRAM (ELP)

The Executive Leadership Program (ELP) is designed for EX-level Directors and Senior Directors in the Canadian public service who are navigating the demands of modern, complex governance. Delivered through a blended format of in-person and virtual sessions, the program fosters meaningful peer dialogue, expert-led discussions, and reflective learning. Participants explore six core themes-**Resilience**, **Vision and Strategies, Ambiguity, Collaboration, Complexity, and Innovation and Change** - to develop the mindset and tools needed to be an effective leader. ELP helps participants deepen their strategic thinking, expand their networks, and lead with purpose in service to Canadians.

WHO SHOULD ATTEND

DURATION

Leaders at the EX1 or EX2 / Director or Senior Director Level.

7 months; includes an in-person session at the beginning, at mid-point, and at graduation. Remainder are delivered virtually in 3 halfdays per month.

LEADERSHIP DEVELOPMENT PROGRAM IN SCIENCE AND INNOVATION (LDPSI)

The Leadership Development Program in Science and Innovation (LDPSI) focuses on how government scientists and policy experts can collaborate in public sector decision-making. Participants learn from theory, guest speakers, hands-on learning, self-awareness tools, coaching, mentorship, and a group project. The program equips participants to make an impact and achieve results.

WHO SHOULD ATTEND	EX minus 1 or equivalent in science, technology, and innovation roles preparing for the Executive, or EX 1 or 2 that are new to government or newly appointed to roles with a science or innovation focus.
DURATION	Intensive 9-week hybrid program; beginning first and last 3 days are in person with virtual sessions in-between.

STEPPING INTO THE EXECUTIVE CADRE (SIEC)

The Stepping into the Executive Cadre (SIEC) program prepares public servants in management roles for leadership at the Executive level. Participants engage with theoretical insights, expert guest speakers, self-awareness tools, and group coaching led by seasoned former executive facilitators.

WHO SHOULD ATTEND	EX minus 1 and EX minus 2 level public servants preparing for the Executive Level.
DURATION	Four 3-day modules over 7 months with 3 action-learning group sessions between modules and a leadership study tour.

DIGITAL EXECUTIVE LEADERSHIP PROGRAM (DELP)

Our highly acclaimed Digital Executive Leadership Program (DELP) is designed for public sector leaders at all levels of government who want to better understand the leadership challenges and opportunities of the digital era. DELP provides public sector executives with the digital literacy and leadership skills they need to be effective decision-makers in this rapidly changing policy and service delivery space. DELP is designed to be applicable to those working directly in IT as well as those in programs, service delivery, policy, or internal services.

DURATION	5-day in-person intensive bootcamp with an evening dinner event.




